About the Commission.

SiD would like to commission a choreographer to create a series of works, made up of two duets and one trio on an agreed theme, with an inclusive cast of dancers from Contact Dance Company.

These Arts Council England funded works will be performed in various locations including outdoor spaces. The work will be made through working closely with SiD artistic directors Rachel Liggitt and Ray Jacobs.

The dances performed will create an inspiring intervention for the public that will be present as part of a bigger event such as festivals, fetes, carnivals and conferences. There is an emphasis on audiences experiencing the delight and power of dance in a light and accessible way.

SiD are seeking a disabled or non disabled choreographer who

- Has a passion for creating dances through working with partner work, choreographed sequences and improvised movement.
- Explores new approaches to dance and dance making.
- Embraces and enjoys creating inclusive dances with disabled and non-disabled performers.
- Preferably has experience in outdoor arts.
- Has a minimum of 4 years experience working in dance.
- Has previous experience in working collaboratively and co-creating with dance peers.



The work will include

Working in close association with SiD Co-Artistic Directors Rachel Liggitt and Ray Jacobs and Contact Dance performers to produce a series of 3 high quality new dance works.

The 3 dance pieces will form a series and be stylistically and conceptually linked. The series will include two duets (5-8 minutes in length) and one trio, approximately 10 minutes in length.

The choreographer will work alongside a designer to create a transportable, touring, 'pop up' design to help stage the work.

Preparation and planning with the SiD team (4 days)
Devising and rehearsal (9 days)
A Production week (3 days) including re-rehearsal /dress & tech, and performance sharing
Attendance at the premier of the new work.

Creation of the work will be based in Shrewsbury. The commission is for a total of 16 days.

Terms

We are offering a freelance commission fee of £4,000, plus agreed travel / accommodation reimbursement and support with access requirements.
